

## MyNorth® Lifetime

Withdrawal, income and Annual Bonus rates

## Annual withdrawal and income rate

If you hold a Deferred Lifetime Income account or a Lifetime Income account in MyNorth, the maximum you can withdraw or take as income is set out in the maximum annual withdrawal and income rate table below.

There are two rates in the table, one for a single life and one for the Couples Option.

You can work out your maximum withdrawal or income amount using the applicable rate and multiplying it by your account balance.
